This liberal conception has difficulty in solving conflicts such as civil wars characterized typically by fundamental disagreements between different communities. In 1980, he obtained his PhD in Political Sciences at the Institut universitaires de hautes études internationales (IUHEI) of the University of Geneva.

Alexis Keller is Professor at the Faculty of Law, University of Geneva. He is a former fellow of the Carr Centre for Human Rights Policy at the Kennedy School of Government, Harvard University. In April 2003, he was appointed by the Swiss Foreign Minister to serve as special representative for the Middle East peace process. He held this post until January 2004.
